Description and Specifications:

The Illinois Tollway is giving notice of intent to renew contract 13-0056 Roadway Sweepings Pick-up and Disposal Services with Independent Recycling Services Inc.

This contract provides a source for the continued purchase of roadway sweepings pickup and disposal services for ten Tollway maintenance sites. Roadway sweepings are classified as non-hazardous roadway debris (gravel, dirt, glass, paper, etc.) collected primarily by Tollway sweeper trucks. The sweepings are stored in ten-yard, vendor-supplied, roll-off dumpsters. The current contract will expire on 12/14/2017 and after execution of this renewal there will be two remaining renewal options.

The contract was originally awarded under reference #22031155.

The renewal term of the contract shall not exceed \$498,174.12 without a formal change order
